Disaster Preparedness Network- Nepal (DPNet-Nepal) is a national umbrella organization of national and international agencies, established in 1996 with an objective of coordination, collaboration, learning and sharing of the experiences and to avoid duplication in emergency response in the country. Since its establishment, the network is working in the field of Disaster Management focusing on knowledge management, capacity building policy advocacy and coordination and networking with government agencies and relevant stakeholders. With reference to the new federal structure of the country, DPNet-Nepal is extending its secretariat in all provinces, through its member organizations.

DPNet-Nepal has unique relation with the Government of Nepal especially with the Ministry of Home Affairs (MoHA) to bridge the gap between governmental and non-governmental agencies in the field of disaster management. 


# **Objectives**

DPNet-Nepal aims to promote disaster risk reduction and management (DRR&M) throughout the country linking disaster to development. The overall objective of DPNet-Nepal is to strengthen coordination, enhance knowledge and capacity of stakeholders in DRR&M and policy advocacy for the legal provisions and contextual issues in DRR.

## **Working Modality**

DPNet-Nepal focuses it's program on the basis of four thematic areas Knowledge Management, Capacity Building, Coordination and Networking and Policy Advocacy. The network closely works with government of Nepal along with humanitarian stakeholders in the field of disaster risk reduction and management. DPNet-Nepal receives technical and financial support from I/NGO's, UN agencies, Corporate sectors and supports government of Nepal for DRR related legal frameworks and other pertinent DRR works.



# **Major Achievements**

- Conducted various advocacy activities for the need of comprehensive disaster management Act and Policy since 2007.
- Organized various National, Regional and International program on Disaster Management. Supported

government of Nepal, MoHA to organize thematic working groups meeting, district and regional level consultation workshop for the formulation of Disaster Risk Reduction National Policy and Disaster Risk Reduction National Strategic Action Plan.

- As per the recommendation of the workshop organized by DPNet Nepal in 2008, MoHA adopted11 clusters approach for disaster preparedness and response in the country.
- Since 2009, in DPNet-Nepal's coordination, MoHA along with supporting partners has been publishing Nepal disaster report (NDR) in every two years.
- As part of knowledge management, DPNet-Nepal has been translating DRR related documents in Nepali and braille tactile signs.
- Organized South Asian Regional workshop on "South Asia Together for Humanitarian Imperative" and the charter was signed by a DRR network of six different countries.
- On behalf of Nepal Risk Reduction Consortium (NRRC) and in coordination and support of flagship leads and responsible government line ministries, DPNet-Nepal, organized flagship program workshops on each flagship area.
- DPNet-Nepal has been collaborating with the Ministry of Home Affairs (MoHA) to provide technical support in preparation and coordination for each AMCDRR.
