- Social Protection Civil Society Network (SPCSN) is a liberal forum comprising 16 non-government organizations (NGOs), which are actively engaging themselves in the sector of human rights and social protection
- Established on 16 February 2012
- Member organizations are dedicated to work with the most vulnerable groups in Nepal such as children, elderly people, people with disability, traffic survivors, people with HIV/AIDS, single women, landless people and so on.
- SPCSN is recognized by the government and is a member of the COVID-19 response coordination committee under the Ministry of Women Children and Senior Citizen

#### SPCSN's major works in the year 2021

- Publication of the Journal of Social Protection <u>link</u>.
- Telecast of Samajik Surakshya Bahas on Kantipur Television <u>Link</u> <u>Here</u>. (25 August 2021, Every Wednesday 9 PM to 10 PM)
- Circulated appeal letter to increase the amount of the Child Nutrition Grant to 753 local units, NCRC, NHRC etc.
- Published the poster on the child nutrition grant in the collaboration with DoNIDCR.
- On-going research on the disaster responsive social protection in Kalaiya, Bara and Helambu, Sindhupalchowck districts.

## SPCSN's major works in the year 2021

- Capacity building of civil society organizations in the areas of social protection in coordination with the Department of National ID and Civil Registration, Social Security Fund, Department of Health – Health Insurance Division, UNICEF, , FCDO (DFID), ILO, World Bank, Save the Children, and individual experts-around 100 NGOs/1140 participants took part in the orientation programmes.
- Several recommendations provided by SPCSN on the draft national social protection framework.
- Suggested recommendations on the draft of 10th year plan for children to the NCRC.

## **SPCSN's Future Plan**

- Continue Capacity Building of CSOs and Advocacy Works related to different areas of Social Protection.
- Study/Research to generate evidences and good practices in the areas of social protection.
- Publish a Second version of Social Protection Journal.
- Develop SPCSN as a resource center for Social Protection

#### Shock Responsive Social Protection and Forecast Based Financing/Actions are the major parts of capacity building and advocacy works for us as:

- Shock Responsive Social Protection was not taken into consideration during COVID-19 response and disasters in Helambu even though there were some good initiatives during 2015 earthquake response
- Considering the disaster context in Nepal and the existing strong social security allowance program implementation system in place We see the clear potentiality (more in universal child grant area) of SRSP to reach out the most vulnerable people quickly and in cost effective way.

Shock Responsive Social Protection and Forecast Based Financing/Actions are the major parts of capacity building and advocacy works for us as:

- Extreme weather forecasts and early warning system required to also coming out in our context, so we need to start the discourse with government as well as non-government sectors.
- CSOs' roles to ensure structural engagement in the policy design and planning processes i.e. Integrated National Social Protection Framework
